### Qualifier Information

#### **Practice Round Information:**

Available: Friday, October 26 and in advance by availability.

Call (803) 754-8109 to schedule a practice round.

Practice round fee: \$35, regardless of cart rental. Players may rent a golf cart for the practice round.

#### **Caddies/Transportation:**

**Participants must walk at all times during the qualifying round, with the exception of any Committee-provided shuttles.**

Caddies are allowed to transport clubs in motorized carts during the qualifying round for a fee of \$25.

**Push/Pull carts are permitted.**

#### **Range:**

Range balls will be available at no cost. The range will be open at 7:00 a.m. on the day of competition.

#### **Starting Times:**

First round starting times will begin at 11:30 a.m. off hole #1. Starting times will be emailed to competitors by October 15, 2018.
