

# 5<sup>th</sup> Women's Match Play Championship of the Carolinas Golf Association

July 16-19, 2002  
Regent Park Golf Club, Fort Mill, SC

## ELIGIBILITY

Entry is open to any female (at birth) amateur golfer who is a legal resident of one of the Carolinas, is a member in good standing of a club which is a member of the Carolinas Golf Association and has a current (within 90 days of opening date) CGA handicap index. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct.

## RULES

USGA Rules of Golf govern play. Local rules will be distributed at the starter's table. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Dress Code: No cut-off shorts or denim, no shorts shorter than four inches above the knees, no tank tops or t-shirts, and all shirts must have either a collar or sleeves. Note: During the stipulated round, use of electronic telecommunications equipment and the like will NOT be allowed.

## FORMAT

The championship is conducted at match play. The field will be divided into flights by scores after the 18-hole stroke play qualifying round. Based on a full field, there will be four flights. The championship flight will be comprised of 16 players, who will compete at match play. All other flights will have 8 players for match play.

## PRIZES

Prizes (merchandise) will be awarded to flight winners (\$75 & trophy) and runners-up (\$25 & trophy), medalist (\$100 & trophy); champion (\$500 & trophy), runner-up (\$300 & trophy), semifinalists (\$200) and quarterfinalists (\$150) in the championship flight.

## ENTRIES

Each entrant must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier. Confirmation of acceptance and lodging information will be sent to players when their status is determined. Status may be checked weekly at [www.thecga.org](http://www.thecga.org).

Entries must be returned to the Carolinas Golf Association, PO Box 319, West End, NC 27376. Fax, e-mail, telephone, late or incomplete entries will not be accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Daily cart fees are not included in the entry fee. Competitors may walk but must pay a cart fee during practice and championship rounds. Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Refunds are not made after entries close except in the case of a verified player illness or death in the family. Refunds are not made for any reason on or after July 12.

Pairings and starting times will be posted at the club and at [www.thecga.org](http://www.thecga.org) the day before the championship. Special requests for starting times or pairings are not granted.

Championship flight: First round matches (18 holes).

First-Third flights: First round matches (18 holes).

### **Thursday, July 18**

Championship flight: Quarterfinal and semifinal matches (18 holes each round).

First-Third flights: Semifinal and Final Matches (18 holes each round).

### **Friday, July 19**

Championship Flight: Final match (18 holes).
