## ELIGIBILITY

Entry is open to any male amateur golfer who is a legal resident of one of the Carolinas, is a member in good standing of a club which is a member of the Carolinas Golf Association and has a current CGA handicap index. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. **The maximum allowable handicap index is 5.4 as of the opening date.**

## RULES

USGA Rules of Golf govern play. Local rules will be distributed at the starter's table. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated, including the alteration of the stipulated round(s) at any time during the championship. *Note: During the stipulated round, use of cell phones, pagers, beepers and the like will NOT be allowed.*

## PRIZES

Trophies will be awarded to the champion, runner-up, medalist, members of the winning team of the Capers Cup Competition, and to medalist(s) at qualifying sites. Merchandise will be awarded to the medalist(s) at qualifying sites and the 32 players who qualify for match play. The Richard S. Tufts Trophy will be held for the ensuing year by the champion.

## ENTRIES

Each entrant must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier. Confirmation of acceptance and lodging information will be sent to players after entries close.

Entries must be returned to the Carolinas Golf Association, P.O. Box 319, West End, NC 27376. Fax, telephone, late or incomplete entries will not be accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Daily cart fees (per round) are not included in the entry fee.

Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Refunds are not made after entries close except in the case of a verified player illness or death in the family. Refunds are not made for any reason after the qualifying round for qualifying players or after July 6 for exempt players.

## SECTIONAL QUALIFYING

Exempt players, if otherwise eligible, include: champions of the Carolinas Amateur since 1991, champions of the North Carolina Amateur since 1996, champions of the South Carolina Amateur Match Play since 1996, champions of the Carolinas Mid-Amateur since 1996, champions of the North Carolina Mid-Amateur since 1996, players who qualified for match play in the 2000 Carolinas Amateur, the 2000 Carolinas Senior Amateur champion, the 2000 North Carolina Senior Amateur champion, the 2000 North Carolina Junior champion, the 2000 CGA South Carolina Junior Champion, the 2000 Carolinas Junior Champion, non-senior/junior playing members of the 2000 Carolinas-Virginias Team Matches, and players ranked in the Top 20 of the CGA Men's Amateur Rankings as of 5/7/01. Also, 2001 U.S. Public Links Championship contestants, 2001 U.S. Open Championship contestants, current USGA and NCAA individual champions, most recent Walker Cup Team members, and current club champion of Dunes Golf and Beach Club are exempt in addition to any special exemptions the CGA may wish to bestow.

Competitors may walk but must pay a cart fee during practice and qualifying rounds. If a qualifying site attracts more players than can be accommodated, some players will be assigned to another site or be rejected. Assignment or rejection is based on the date the CGA receives each entry form and cannot be changed. Site assignments cannot be changed after entries close. Individual qualifying site information will be sent after entries are accepted.

## Schedule of Play at The Dunes Golf and Beach Club

Tuesday, July 10	Course open for practice.
Wednesday, July 11	First round of qualifying.
Thursday, July 12	Second round of qualifying. Cut to low 32 scorers for match play.
Friday, July 13	First and second rounds of match play.
Saturday, July 14	Quarterfinal and semifinal rounds of match play.
Sunday, July 15	Final match (36 holes).

Pairings and starting times will be posted on the CGA web site ([www.theccga.org](http://www.theccga.org)) and at the club the day before the championship. Special requests for starting times or pairings are not granted.
