

The 21st Mid-Amateur Championship of the Carolinas Golf Association

ELIGIBILITY

Entry is open to any male amateur golfer who has reached his 30th birthday by the first day of the championship, is a legal resident of one of the Carolinas, is a member in good standing of a club which is a member of the Carolinas Golf Association and has a current CGA handicap index. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. **The maximum allowable handicap index is 5.4 as of the opening date.**

RULES

USGA Rules of Golf govern play. Local rules will be distributed at the starter's table. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated, including the alteration of the stipulated round(s) at any time during the championship. *Note: During the stipulated round, use of cell phones, pagers, beepers and the like will NOT be allowed.*

PRIZES

Prizes will be awarded in merchandise at the championship and at qualifying sites. The Darby Moore Trophy will be held by the winner for the ensuing year.

ENTRIES

Each player must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier. Confirmation of acceptance and lodging information will be sent to players after entries close.

Entries must be returned to the Carolinas Golf Association, P.O. Box 319, West End, NC 27376. Fax, telephone, late or incomplete entries will not be accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check.

Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Refunds are not made after entries close except in the case of a verified player illness or death in the family. Refunds are not made for any reason after the qualifying round for qualifying players or after September 10 for exempt players.

SECTIONAL QUALIFYING

Exempt players, if otherwise eligible, include: champions of the Carolinas Amateur since 1991, champions of the Carolinas Mid-Amateur since 1991, champions of the North Carolina Amateur since 1996, champions of the CGA South Carolina Match Play since 1996, champions of the North Carolina Mid-Amateur since 1996, the 2000 Carolinas Amateur runner-up, the 2000 Carolinas Senior Amateur champion, the 2000 North Carolina Senior Amateur champion, non-senior/junior playing members of the 2000 Carolinas-Virginias Team Matches, players who finished 30th or better in the 2000 Carolinas Mid-Amateur, and players ranked in the Top 20 of the CGA Carolinas Men's Amateur Rankings as of 7/9/01. Also, 2001 U.S. Public Links Championship contestants, 2001 U.S. Open Championship contestants, 2001 U.S. Amateur Championship contestants, 2001 U.S. Mid-Amateur Championship contestants, current USGA individual champions, most recent Walker Cup Team members, and current club champion of Palmetto Golf Club are exempt in addition to any special exemptions the CGA wishes to bestow.

Competitors may walk but must pay a cart fee during practice and qualifying rounds. If a qualifying site attracts more players than can be accommodated, some players will be assigned to another site or be rejected. Assignment or rejection is based on the date the CGA receives each entry form and cannot be changed. Site assignments cannot be changed after entries close. Individual qualifying site information will be sent after entries are accepted.
