

# The 8<sup>th</sup> North Carolina Mid-Amateur Championship of the Carolinas Golf Association

## ELIGIBILITY

Entry is open to any male amateur golfer who has reached his 30<sup>th</sup> birthday by the first day of the championship, is a legal resident of North Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association and has a current CGA handicap index. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. **The maximum allowable handicap index is 5.4 as of the opening date.**

## RULES

USGA Rules of Golf govern play. Local rules will be distributed at the starter's table. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. *Note: During the stipulated round, use of cell phones, pagers, beepers and the like will NOT be allowed.*

## PRIZES

Prizes will be awarded in merchandise at the championship and at qualifying sites. The championship trophy will be held by the winner's club for the ensuing year.

## ENTRIES

Each entrant must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. Confirmation of acceptance and lodging information will be sent to players after entries close.

Entries must be returned to the Carolinas Golf Association, P.O. Box 319, West End, NC 27376. Fax, telephone, late or incomplete entries will not be accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Daily cart fees are not included in the entry fee.

Make check payable to the Carolinas Golf Association. The CGA is not responsible for errors or delays by any mail courier. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Refunds are not made after entries close except in the case of a verified player illness or death in the family. Refunds are not made for any reason after the qualifying round for qualifying players or after April 2 for exempt players.

## SECTIONAL QUALIFYING

Exempt players, if otherwise eligible, include: champions of the Carolinas Amateur since 1991, champions of the North Carolina Mid-Amateur since 1994, champions of the Carolinas Mid-Amateur since 1996, champions of the North Carolina Amateur since 1996, champions of the CGA South Carolina Amateur Match Play since 1996, the 2000 Carolinas Amateur runner-up, the 2000 Carolinas Senior Amateur champion, the 2000 North Carolina Senior Amateur champion, non-senior/junior playing members of the 2000 Carolinas-Virginias Team Matches, players who finished 30<sup>th</sup> or better in the 2000 North Carolina Mid-Amateur, and players ranked in the Top 20 of the CGA Carolinas Men's Amateur Rankings as of 2/12/01. Also, current USGA individual champions, most recent Walker Cup team members, and current club champion of River Landing CC are exempt in addition to any special exemption the CGA may wish to bestow.

Competitors may walk but must pay a cart fee during practice and qualifying rounds. If a qualifying site attracts more players than can be accommodated, some players will be assigned to another site or rejected. Assignment or rejection is based on the date the CGA receives each entry form and cannot be changed. Site assignments cannot be changed after entries close. Individual qualifying site information will be sent after entries are accepted.

## Schedule of Play at River Landing Country Club

Thursday, April 5	Course open for practice.
Friday, April 6	First round of stroke play.
Saturday, April 7	Second round. Cut to low 60 players and ties.
Sunday, April 8	Final round.

Pairings and starting times will be posted on the CGA web site ([www.thecga.org](http://www.thecga.org)) and at the club the day before the championship. Special requests for starting times or pairings are not granted.
