#### Eligibility

Entry is open to any female (at birth) golfer who is a member in good standing of a club which is a member of the Carolinas Golf Association and has current (within 90 days) CGA handicap index. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct.

#### Rules

USGA Rules of Golf govern play. Local rules will be distributed at the site. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated. The CGA official in charge reserves the right to withhold prizes for competitors whose handicaps are considered unrealistic or who have participated in a disproportionate share of CGA prize distributions.

#### Format

Players will compete at individual stroke play using full course handicap. **Play will begin play with a shotgun start at 9:30 a.m.** An awards luncheon will follow.

#### Entries

**Online entry applications may be completed at [www.carolinanogolf.org](http://www.carolinanogolf.org).** Each entrant must complete an official entry form. No entry will be accepted prior to the opening date. Entries will be accepted until 5 p.m. of the closing date. The CGA is not responsible for errors or delays made by any mail or delivery courier. Fax, e-mail, telephone, late or incomplete entries are not accepted. Confirmation of acceptance will be mailed. Pairings will be available at the host club and on the internet at [www.carolinanogolf.org](http://www.carolinanogolf.org). Entries must be returned to the **Carolinan Golf Association, PO Box 319, West End, NC 27376**. The entry fee must be paid by each entrant and must accompany this form. Only one entry per check. Make check payable to Carolinas Golf Association. A check returned for insufficient funds may cause disqualification from future CGA competitions. **A \$10 administrative fee is deducted from all refunds.** Refunds are not made for any reason after entries close.
