

# 8<sup>th</sup> Women's Senior Championship of the Carolinas Golf Association

## ELIGIBILITY

Entry is open to any female (at birth) amateur golfer who has reached her 50<sup>th</sup> birthday by the first day of the championship, is a legal resident of one of the Carolinas, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA handicap index at a CGA member club. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. For complete residency and eligibility requirements, refer to the CGA Tournament Manual at [www.carolinascgolf.org](http://www.carolinascgolf.org).

## RULES

USGA Rules of Golf govern play. Local rules are distributed at the starter's table. The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Dress code: No cut-off shorts or denim, no shorts shorter than four inches above the knees, no tank tops or t-shirts, and all shirts must have either a collar or sleeves. Note: During the stipulated round, use of electronic telecommunications equipment and the like are **NOT** allowed. The competition shall be deemed to have closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

## FORMAT

The championship is contested at 36 holes of stroke play with a championship division and a super senior division (ages 65+). Players are flighted by gross scores after the first round. Players who are age 65 and over may opt to play in the championship division but waive any right to prizes in the super senior division. The super senior division plays a shorter course.

## PRIZES

Prizes and merchandise are awarded to the overall champion and super senior champion. Prizes and merchandise are awarded to low gross winners in each flight. A tie for the overall champion and super senior champion is decided by an on-course play-off. Ties for trophies and merchandise in each division is broken by a score card play-off. Ties for merchandise only is split.

## GOLF CARTS/CADDIES

Championship cart fees are included in the entry fee. Cart rental may be mandatory for practice rounds. Competitors must use golf carts during championship rounds. Caddies are allowed for championship rounds.

## ENTRIES

Each entrant must complete an official entry form. Online entry applications can be completed at [www.carolinascgolf.org](http://www.carolinascgolf.org). Entries are accumulated for the entire open/close window. Exempt players are accepted at time of entry. The remainder of the field is selected after entries close by handicap index and past CGA tournament record. No entry is accepted prior to the opening date. Entries are accepted until 11:59 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Confirmation of acceptance and lodging information is sent to players when their status is determined. Status may be checked at [www.carolinascgolf.org](http://www.carolinascgolf.org). Fax, e-mail, telephone, late or incomplete entries are not accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) jeopardize their entry into future Carolinas Women's Senior championships.

## REFUND POLICY

Entry fee will be refunded regardless of reason if the CGA is notified before close of entries. Refunds are not made after entries close except in the case of player injury, illness or death in the family. A \$20 administrative fee is deducted from all refunds.

Detach, sign and mail the entry form with your fee to CGA, PO Box 319, West End, NC 27376. Entry fee is \$120 and includes championship round cart/range fees and lunch. Incomplete, illegible forms and entries received before the opening date are returned. Keep the bottom portion for your records.

## EXEMPTIONS

Exempt players, if otherwise eligible, include: all former champions of the Carolinas Women's Senior Championship, all former champions of the North Carolina Women's Senior Championship, all former champions of the Women's South Carolina Golf Association Senior Championship, senior playing members of the 2005 Carolinas Women's Team and players ranked in the Top 10 of the CGA Carolinas Senior Women's Amateur Rankings as of 2/27/06. Also, players who finished 10<sup>th</sup> or better in the 2005 Carolinas Women's Senior, current USGA individual champions, 2005 USGA Championship qualifiers and the current senior women's club champion of Raintree Country Club as of the opening date are exempt in addition to any special exemption the CGA may wish to bestow.
