**ELIGIBILITY**

Entry is open to any female amateur golfer who has not reached her **19<sup>th</sup>** birthday by the last day of the championship, has not started college, is a legal resident of one of the Carolinas; and the junior golfer, parent or guardian is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA). Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. For complete residency and eligibility requirements, refer to the CGA Tournament Manual at [www.carolinagolf.org](http://www.carolinagolf.org).

**RULES**

USGA Rules of Golf govern play. Local rules are distributed at the starter's table. The Carolinas Golf Association reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Each competitor must walk and carry her own bag (pull carts allowed if club agrees) during the stipulated round, unless the player employs a caddie. In that case, the caddie must be **18 or younger** and must walk. Use of tobacco products by competitors or caddies is prohibited. Note: During the stipulated round, use of electronic telecommunications equipment and the like are NOT allowed. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

**JUNIOR DIVISION**

Junior division will be made of any girl 13 years of age or older, or under the age of 13 with a handicap index less than 15.0. Players in the junior division will play an 18-hole qualifying round and up to four 18-hole rounds of match play.

**SUB-JUNIOR DIVISION**

Sub-junior division will be made of any girl less than 13 years of age with a handicap index of 15.0 or higher. Players in the sub-junior division will play a 9-hole stroke play qualifying round and up to three 9-hole matches.

**FIELD SIZE**

The field will be limited to 64 juniors and 12 sub juniors. Entry acceptance will be determined by handicap index and past tournament participation. A waiting list will be formed with remaining entries. E-mail notification of acceptance or waiting list status, will be sent after the close of entries.

**CHAMPIONSHIP FORMAT AND YARDAGE**

The championship is conducted at match play. **Defending champion, Eleana Collins of Pinehurst, NC will be seeded number one in the championship flight, if otherwise eligible.** The Championship Flight will be made up of the top 15 qualifiers. All other flights will consist of 8 players each. The Committee reserves the right to make adjustments in the size of each flight. The yardage for the championship will be approx. 5850 yards. The sub-juniors will play from a yardage of approx. 5289 yards.

**PRIZES AND TEAM MATCHES**

Trophies will be awarded to the champion, runner-up and semi-finalists in the championship flight, the champion and runner-up in all other flights, the winner and runner-up of the championship consolation flight and winner of all other consolation flights. Trophies will also be awarded to the medalist and most improved player from the stroke play qualifying for each division. The overall champion and runner-up will be invited to represent the CGA in the Mid-Atlantic Challenge, August 4-5, 2007 at the Country Club of North Carolina, Pinehurst, NC.

**ENTRIES**

Each entrant must complete an official entry form. Online entry applications can be completed at [www.carolinagolf.org](http://www.carolinagolf.org). No entry is accepted prior to the opening date. Entries are accepted until 11:59 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Confirmation of acceptance and lodging information is sent to players when their status is determined. Status may be checked at [www.carolinagolf.org](http://www.carolinagolf.org). Fax, e-mail, telephone, late or incomplete entries are not accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) jeopardize their entry into future CGA Junior championships.

**REFUND POLICY**

Entry fee will be refunded regardless of reason if the CGA is notified before close of entries. Refunds are not made after entries close except in the case of player injury, player illness or death in the family. Refunds are not made regardless of reason for players who have played in a qualifier. A \$20 administrative fee is deducted from all refunds.
