

22nd North Carolina Senior Amateur Championship

ELIGIBILITY

Entry is open to any male amateur golfer who has reached his 55th birthday by the first day of the championship, is a legal resident of North Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA handicap index® at a CGA member club. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. For complete residency and eligibility requirements, refer to the CGA Tournament Manual at www.carolinagolf.org. **The maximum allowable index is 10.4 for championship division and 15.4 for Super Senior division (70 and over).**

RULES

USGA Rules of Golf govern play. Local rules are distributed at the starter's table. The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Note: During the stipulated round, use of electronic telecommunications equipment and the like are NOT allowed. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

FORMAT AND PRIZES

The championship format is 54 holes of stroke play. After 36 holes, the field is cut to low 60 scorers and ties for the final round. The super senior division competes at 36 holes of stroke play with no cut and plays a shorter course. Players who are age 70 and over and who meet the handicap requirement may opt to play in the championship division but waive any right to prizes in the super senior division. The super senior division is re-paired according to score after the first round. Field size: Championship (120 approximately); Super Senior (24 lowest indexes). Champion receives a trophy, merchandise and possession of the Peter V. Tufts Trophy for the ensuing year. Championship division pays top 30 places. The super senior champion receives a trophy. Super senior division pays a minimum of five places. An on-course playoff is used to break a tie for the overall champion or super senior champion.

GOLF CARTS/CADDIES/RANGE FEES

Daily cart and range fees are not included in the entry fee. Caddies are allowed for sectional qualifying and championship rounds.

Sectional Qualifying: Cart and range fee is mandatory for sectional practice and qualifying rounds.

Championship Site: Cart rental may be mandatory for practice rounds. Competitors have the option to either walk or rent a golf cart during championship rounds.

ENTRIES

Each entrant must complete an official entry form. Online entry applications can be completed at www.carolinagolf.org. No entry is accepted prior to the opening date. Entries are accepted until 11:59 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Confirmation of acceptance and lodging information is sent to players when their status is determined. Status may be checked at www.carolinagolf.org. Fax, e-mail, telephone, late or incomplete entries are not accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) jeopardize their entry into future N.C. Senior championships.

REFUND POLICY

Entry fee will be refunded regardless of reason if the CGA is notified before close of entries. Refunds are not made after entries close except in the case of player injury, player illness or death in the family. Refunds are not made regardless of reason for players who have played in a qualifier. A \$20 administrative fee is deducted from all refunds.

EXEMPTIONS AND SECTIONAL QUALIFYING

***Complete list of exempt players available online at www.carolinagolf.org**

Championship Division Exemptions: Championship division players exempt from sectional qualifying, if otherwise eligible, include: champions of the North Carolina Senior Amateur since 1997, champions of the Carolinas Senior Amateur since 1997, champions of the SCGA South Carolina Senior Amateur since 2002, individual champions of CGA and SCGA championships since 2002, members of the 2006 Carolinas Team, 2006 Carolinas Men's and Senior Men's Player of the Year, players who finished 30th or better at the 2006 North Carolina Senior Amateur Championship, and players ranked in the Top 20 of the CGA Carolinas Senior Men's Amateur Rankings as of 4/11/07. Past CGA individual champions are exempt in all CGA senior individual events for a period of one year from the date of their 55th birthday. Also, current USGA individual champions, 2006 USGA Championship qualifiers, the current senior club champion of Pinewood Country Club, as of the closing date, are exempt in addition to any special exemption the CGA may wish to bestow.

Super Senior Division Exemption: The 2006 N.C. Super Senior champion is exempt into the super senior division.

Sectional Qualifying - 18 Holes. Sectional qualifying is only for the Championship division. The number of qualifiers' places at each qualifying site is determined by the CGA after entries close, based on the size of the field. All ties for the final qualifying position qualify for the championship. If a qualifying site attracts more players than can be accommodated, some players are assigned to another site or rejected. Assignment or rejection is based on the date the CGA receives each entry form and cannot be changed. **Site assignments cannot be changed after entries close.** Individual qualifying site information is sent after entries are accepted. A player may choose to qualify at only one site. If that qualifying site is full at the time the entry is received, that player is listed as an alternate at that qualifying site.
