

# 35<sup>th</sup> South Carolina Amateur Match Play Championship

June 13-17, 2007

True Blue Golf Club, Pawleys Island, SC

## ELIGIBILITY

Entry is open to any male amateur golfer who is a legal resident of South Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA handicap index® at a CGA member club. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. For complete residency and eligibility requirements, refer to the CGA Tournament Manual at [www.carolinascgolf.org](http://www.carolinascgolf.org). **The maximum allowable handicap index is 7.4.**

## RULES

USGA Rules of Golf govern play. Local rules are distributed at the starter's table. The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Note: During the stipulated round, use of electronic telecommunications equipment and the like are NOT allowed. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

## FORMAT AND TEAM COMPETITION

Championship format is 36 holes of stroke play to determine 32 qualifiers for match play. The defending champion is seeded number one for match play if otherwise eligible. A team competition is held in conjunction with stroke play qualifying. Three or four competitors from the same club comprise a team. The lowest three scores count each round. When more than four competitors from the same club are in the field, the lowest handicap indexes are used to determine the team unless the CGA is informed otherwise.

## PRIZES

Champion receives a trophy, merchandise and possession of the permanent championship trophy for the ensuing year. Prizes are awarded to the medalist, runner-up, semifinalists, quarterfinalists and members of the winning club in the team competition.

## GOLF CARTS/RANGE FEES/CADDIES

Daily cart and range fees are not included in the entry fee. **Due to True Blue's course layout, cart rental and use is mandatory for all practice and championship rounds.** Competitors are responsible for paying cart rental fees prior to each championship round. Caddies are allowed.

## ENTRIES

Each entrant must complete an official entry form. Online entry applications can be completed at [www.carolinascgolf.org](http://www.carolinascgolf.org). No entry is accepted prior to the opening date. **Entries are accumulated for the entire open/close window. Exempt players are accepted at time of entry. The remainder of the field is selected after entries close by handicap index.** Entries are accepted until 11:59 p.m. of the closing date. The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Confirmation of acceptance and lodging information is sent to players when their status is determined. Status may be checked at [www.carolinascgolf.org](http://www.carolinascgolf.org). Fax, e-mail, telephone, late or incomplete entries are not be accepted. The entry fee must be paid by each player and must accompany this form. Only one entry per check. Make check payable to the Carolinas Golf Association. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) jeopardize their entry into future S.C. Amateur Match Play championships.

## REFUND POLICY

Entry fee will be refunded regardless of reason if the CGA is notified before close of entries. Refunds are not made after entries close except in the case of player injury, player illness or death in the family. A \$20 administrative fee is deducted from all refunds.

Exempt players, if otherwise eligible, include: champions of the South Carolina Amateur Match Play Championship since 1997, champions of the Carolinas Amateur since 1997, champions of the SCGA Amateur since 1997, champions of the Carolinas Mid-Amateur since 2002, champions of the SCGA Mid-Amateur since 2002, the 2006 Carolinas Amateur runner-up, the 2006 Carolinas Senior Amateur champion, the 2006 SCGA Senior Amateur champion, the 2006 South Carolina Junior Match Play Champion, the 2006 Carolinas Junior champion, the 2006 SCGA Junior champion, non-senior/junior playing members of the 2006 Carolinas Team, players who qualified for the round of 32 at the 2006 South Carolina Amateur Match Play Championship, 2006 Carolinas Men's and Senior Men's Player of the Year and players ranked in the Top 20 of the CGA Carolinas Men's Amateur Rankings as of 6/4/07. Also, current USGA individual champions, 2006 USGA Championship qualifiers, the current club champion of True Blue Golf Club as of the closing date are exempt in addition to any special exemption the CGA may wish to bestow. Adam Hart of Blythewood, SC is the defending champion and is seeded number one for match play if otherwise eligible.

First round: 18 holes of stroke play.

### Thursday, June 14

Second round: 18 holes of stroke play. Field cut to low 32 qualifiers for match play.

### Friday, June 15

First and second rounds of match play (18 holes each round).

### Saturday, June 16

Quarterfinal and semifinal rounds of match play (18 holes each round).

### Sunday, June 17

Final match (36 holes).
