

# 5th North Carolina Women's Senior Championship

## ELIGIBILITY

Entry is open to any female (at birth) amateur golfer who has reached her 50<sup>th</sup> birthday by the first day of the championship, is a legal resident of North Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA handicap index® at a CGA member club. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. ## RULES

USGA Rules of Golf govern play. Local rules are distributed at the starter's table. The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. Dress code: No cut-off shorts or denim, no shorts shorter than four inches above the knees, no tank tops or t-shirts, and all shirts must have either a collar or sleeves. Note: During the stipulated round, use of electronic telecommunications equipment and the like are NOT allowed. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

## FORMAT

The championship is contested at 36 holes of stroke play with a championship division and tournament division (shorter course). Players are assigned into flights by first round gross scores within their division. Players have the option to compete in either the "Championship" division or "Tournament" division. "Tournament" division plays a shorter course and is ineligible for the overall championship.

## PRIZES

Prizes and merchandise are awarded to the overall champion. Merchandise is awarded to gross winners in each flight. A tie for the overall champion is decided by an on-course play-off. Ties for trophies and merchandise in each division are broken by a score card play-off. Ties for merchandise only are split. Prizes for Super Senior players (age 65+) will be awarded in the "Tournament" division.

## GOLF CARTS/RANGE FEES

**Championship cart/range fees and lunch after final round are included in the entry fee.** Cart rental may be mandatory for practice rounds. Competitors must use golf carts during championship rounds. Caddies are allowed for championship rounds.

## ENTRIES

Each entrant must complete an official entry form. Online entry applications can be completed at [www.carolinascgolf.org](http://www.carolinascgolf.org). Fax, email, telephone, incomplete, illegible forms, or entries received before the opening date and after the closing date are not accepted. **Entries are accumulated for the entire open/close window. The final field is comprised of players with lowest handicap indexes. Alternates are ranked according to handicap index.** The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Confirmation of acceptance and lodging information is sent to players when their status is determined. Status may be checked at [www.carolinascgolf.org](http://www.carolinascgolf.org). The entry fee must be paid by each player and must accompany this form. Only one entry fee per check. Make check payable to the Carolinas Golf Association. Detach, sign and mail the entry form with your \$120 entry fee to the CGA, PO Box 319, West End, NC 27376. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) jeopardize their entry into future N.C. Women's Senior championships.

## REFUND POLICY

Entry fee will be refunded regardless of reason if the CGA is notified before close of entries. Refunds are not made after entries close except in the case of player injury, player illness or death in the family. A \$20 administrative fee is deducted from all refunds.
