CGA Championship Regulations

These regulations apply to CGA championships.

2010-11 USGA Rules of Golf govern play.

Automotive Transportation

The CGA may require rental of (or rental and use of) automotive transportation at a championship or qualifying event. (Such a requirement does not imply that caddies are prohibited.) Such a requirement is stated on the championship entry form, letter to competitors and/or local rules sheet.

Automotive transportation is prohibited at junior events and other championships as specified in the championship entry form, letter to competitors and/or local rules sheet.

Caddies and Spectator Carts

Caddies are permitted at CGA championships unless otherwise stated in the letter to competitors and the local rules. A competitor should identify his/her caddie to an opponent or to the competitor's marker prior to the start of play. The competitor is responsible for the conduct of the caddie during an event.

At CGA junior events, caddies over the age of 18 are **not** permitted.

CADDIE/SPECTATOR CART POLICY: During the play of a hole, either the player or his caddie may ride in a golf cart but not both at the same time. Spectators are not allowed to ride in a player's golf cart at any time. Club owned spectator carts are not allowed.

Cellular Phones, Portable Music and Electronic Devices

The use of cellular phones (except in the case of an emergency), portable music devices, headphones, laptop computers, PDA's, pagers, beepers, and the like are not allowed during a stipulated round. First offense results in a warning. Second offense results in the player's disqualification.

Championships - Rules and Regulations

The Carolinas Golf Association Executive Committee is responsible for rules and regulations that govern CGA championships. CGA staff or committee members who attend a CGA championship are responsible to the Executive Committee for enforcing regulations. United States Golf Association (USGA) Rules of Golf and local rules govern play.

Classifications of Competitors

AMATEUR is a member of a CGA member club who maintains amateur status as defined by the USGA.

PROFESSIONAL is a member of the golf professional staff of a CGA member club.

JUNIOR is an amateur dependent of a member of a CGA member club who has not reached the 19th birthday by the date listed on a junior entry form and has not started college.

SENIOR MALE is a male amateur member of a CGA member club who has reached his 55th birthday by the date listed on a senior entry form.

SUPER SENIOR MALE is a male amateur member of a CGA member club who has reached his 65th birthday by the date listed on a senior entry form.

SENIOR FEMALE is a female (at birth) amateur member of a CGA member club who has reached her 50th birthday

by the date listed on a senior entry form.

SUPER SENIOR FEMALE is a female (at birth) amateur member of a CGA member club who has reached her 65th birthday by the date listed on a senior entry form.

MID-AMATEUR is an amateur member of a CGA member club who has reached the 30th birthday by the date listed on a mid-amateur entry form.

FATHER-SON is a team comprised of a father and a son, stepfather-stepson or grandfather-grandson. One member of each team must be a member of a CGA member club or a member of the golf professional staff of a CGA member club.

PARENT-CHILD is a team comprised of a father and a daughter, mother-daughter, mother-son, stepfather-stepdaughter, stepmother-stepdaughter, stepmother-stepson, grandfather-granddaughter, grandmother-granddaughter or grandmother-grandson. One member of each team must be a member of a CGA member club or a member of the golf professional staff of a CGA member club.

Code of Conduct

CGA expects all competitors to adhere to the "Etiquette and Behavior on the Course" section of the USGA Rules of Golf. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct, did not start (DNS) or no card (NC). Failure to follow the CGA Code of Conduct may result in the competitor's suspension from participation in future CGA competitions.

Course Preparations

The CGA staff, at the bidding of the championship committee, is responsible for marking a golf course and determining tee and hole locations. Special rules, such as dropping zones, are listed on the Notice to Players.

Defending Champions

In a match play championship, the defending champion is exempt from the next year's match-play qualifying and is seeded first in match play unless these rights are waived. A defending champion **must** complete an entry form for the next year's championship and fulfill all eligibility and deadline requirements.

In a four-ball championship, both competitors of the defending team must enter as one team to retain the exemption.

Discontinuing Play

Competitors are permitted to discontinue play in accordance with Rule 6-8 (USGA Rules of Golf). The championship committee and the host club superintendent or club committee also may discontinue play.

Any interruption of play is noted by a siren blast. When play is discontinued, a competitor should mark and lift his/her ball.

When play is suspended for a dangerous situation, a competitor who is between the play of two holes may not resume play until the committee has ordered a resumption of play. A competitor in any event **must** discontinue play immediately upon announcement of a dangerous situation.

If conditions become so severe that play cannot be resumed the same day, the championship committee may suspend, postpone or cancel the round. When play is suspended, play will be resumed from where it was stopped, and all posted scores stand. When play is postponed, returned scores **may** be canceled at the discretion of the committee. A postponed round is rescheduled immediately for the following day if possible.

Dress Code

The CGA defers to the dress code of a host club but also enforces its own code. Unsuitable attire at championships includes: shirts without collars, pants or shorts made of denim, shorts less than Bermuda length, tank tops, T-shirts and cut-offs.

A competitor who does not conform to a championship dress code will be asked to change attire prior to his/her starting time. The penalty for non-compliance is disqualification.

Eligibility

Eligibility rules are listed on the respective CGA championship entry forms. A CGA amateur championship is open to an amateur golfer who is a legal resident of North Carolina or South Carolina, who has a USGA Handicap Index issued by a CGA member club through the CGA's handicapping service within the last 30 days (except in junior championships), who meets USGA Handicap Index requirements (if applicable), and who meets age requirements listed on the entry form. A competitor may submit only one entry for each championship.

All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf".

The following residency criteria apply only to CGA championships and the qualifiers attendant to those championships:

Legal Residency Criteria: An individual is considered to be a resident of one of the Carolinas when said individual (a) maintains his/her primary residence in North Carolina or South Carolina or if (a) is in question, (b) the individual is registered to vote in North Carolina or South Carolina in local, state and national elections.

Junior Criteria: An eligible junior is an 18-year-old or under who is a dependent of a member of a CGA member club who meets "Legal Residency Criteria" and has not started college. An eligible junior is not required to have a current USGA Handicap Index issued by a CGA member club unless otherwise stated on the championship entry form.

Military Criteria: Active duty members of the United States Military are eligible to participate in CGA Championships if they are stationed in one of the Carolinas as of the last scheduled day of the event and meet (a) in "Legal Residency Criteria". The voting and income tax provisions are waived. They must meet all other eligibility requirements listed on the official tournament entry form.

College Student Criteria: A college student is considered a resident of their parent(s)/guardian(s) "Legal Residency Criteria" as stated above unless said student (a) has no dependency on his/her parents; and (b) lives full time in North Carolina or South Carolina.

Applicants for reinstatement to amateur status (A/R) are not eligible for CGA amateur championships. Professionals are eligible only for professional events (including divisions of the Father-Son and Parent-Child championships) and must conform to the **PROFESSIONAL** classification.

USGA Handicap Index limitations are stated on each championship entry form and must be met on the date listed on the form.

Entrants who misrepresent their playing proficiency are subject to disqualification at any time and to rejection from future CGA events.

The CGA reserves the right to reject an entry if the entrant was a no card (NC) or did not show (DNS) that event the previous year.

Entry Requirements and Deadlines

Entry opening and closing deadlines are strictly observed. Championship entry forms received before the specified opening date are returned to the sender and must be re-submitted.

Every competitor must complete, sign and return an official championship entry form or complete an online application at www.carolinasgolf.org. Forms must be filled out completely and **legibly**. No entry is accepted prior to

a championship's opening date. Entries are accepted until 11:59 p.m. of the closing date listed on the form.

Fax, e-mail, telephone, late or incomplete entry forms are not accepted.

The specified entry fee must be paid by cash, check or money order and must accompany the championship entry form. Checks must be made payable to the Carolinas Golf Association. Visa and MasterCard payments are accepted for online applications only.

While the CGA is pleased to provide online championship applications, we stress that the Internet is an unstable environment. The CGA cannot and does not guarantee that this site or the ability to apply on-line will be available seven days a week, twenty-four hours a day. The CGA does not make any guarantee that an entry submitted pursuant to this site will be received by the CGA or received in a timely fashion. Just as with registration by mail, the responsibility for ensuring that an application is received by the CGA by no later than the deadline set forth on the particular entry form and the risk of delay and/or error in transmission lies solely with the applicant. The CGA shall have no liability with respect to any such delay and/or error and the consequences therefrom, including rejection of an entry. Entries will be automatically rejected by the CGA if received at the CGA after the date and time set forth on the relevant entry form. Please be advised that players who are minors upon the date of submission of an entry form in the state in which they reside (e.g. North Carolina, under the age of 18) must have parental consent to apply via the Internet.

The CGA is not responsible for errors or delays made by any mail, delivery courier, internet service provider or credit card vendor. Confirmation of acceptance and lodging information are sent to competitors as soon as practicable.

Entry into a CGA championship is subject to approval by the CGA Championship Committee. By signing a championship entry form, each entrant agrees to abide by all CGA and club regulations.

Entry Refunds

Entry fee refund policy schedule:

Open Date to Close Date: Full refund minus \$25.00 administrative fee if entry accepted into championship.

Day after Close Date to Day Prior to Championship or Qualifying Date: 50% entry fee refunded regardless of reason.

Withdraw on Championship or Qualifying Date: No refund for any reason.

Refunds are not made for any reason after the qualifying round for qualifying competitors (in championships which have qualifying events).

Credit card registration refunds are credited to the account from which payment was made.

Entries paid by check will either have the check destroyed or a refund check for the appropriate amount will be issued from the CGA office.

Field Size

Field sizes are determined by the CGA.

Exemption from Qualifying Events

In championships which require sectional qualifying events, exemption categories are listed on the championship entry form. All other competitors must qualify.

Gambling

The CGA discourages any form of gambling in connection with any CGA event. Incidents of wagering or gambling considered flagrant or excessive by the committee may result in disqualification of those involved and rejection of entry in subsequent CGA championships.

Local Rules

The CGA Championship Committee is responsible for preparing and distributing the "Notice to Players," including all local rules. These are distributed at the starting tees and are available at the starter's table.

Unless otherwise noted, the following local rules are in effect at CGA championships:

*The "One-Ball Rule" is **not** in effect.*

Embedded ball relief is "through the green" except in sand not in closely mown areas.

Regular water hazards are identified by yellow stakes and defined by yellow lines. Stakes and lines are deemed to be in a hazard.

Lateral water hazards are identified by red stakes and defined by red lines. Stakes and lines are deemed to be in a hazard.

Ground under repair is defined by white lines. White-lined areas tying into a cart path are deemed to be part of that obstruction.

Out of bounds is defined by the inside points of white stakes at ground level and other items as defined in the Notice to Players.

***Distance Measuring Devices:** A player may obtain distance information by using a device that measures distance only. However, if, during a stipulated round, a player uses a distance-measuring device that is designed to gauge or measure other conditions that might affect his play (e.g., gradient, wind-speed, temperature, etc.), the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional functions are actually used.*

*At clubs which have shoe and **spike restrictions**, the penalty for non-compliance of the club rule is **disqualification**.*

*All club **dress codes** will be observed. The penalty for non-compliance is **disqualification**.*

The penalty for non-compliance of the CGA prohibition of cell phones, headphones, MP3 players, beepers, pagers and the like is a warning for the first offense and disqualification for the second offense.

Official Starting Time

Tee Times - The clock at the tee (1st or 10th) where the player begins his/her stipulated round is the official time of starting. Starters will not page players in advance of their starting time. Players should report to the tee at least five minutes prior to their starting time. Rule 6-3b, Note is in effect (Five Minute Rule).

Shotgun or Simultaneous Start - A player is responsible for being at the assigned tee promptly to begin play on time. If a player arrives late but within five minutes after the assigned starting time, the penalty for failure to start on time is two strokes at the first hole instead of disqualification (Rule 6-3b, Note). The assigned starting time for shotgun events is when a) a horn or siren is sounded, b) if no horn or siren is used, when the group can play without interference or c) if the player is in the second group to start on an assigned hole, when that group can play without interference.

Pace of Play

The CGA is concerned about the pace of play in championships. Following the lead of the USGA, the CGA has developed a pace of play policy, based on Rule 6-7, that is fair to every competitor.

Pace of play regulations are stated on the championship local rules sheet. As a general rule, these include:

Any competitor who is discovered taking more than 40 seconds to play a stroke is subject to a warning for slow play and will be advised of the fact. The competitor will be notified that exceeding 40 seconds on one more occasion will result in a penalty of one stroke in stroke play or loss of hole in match play. A third violation will result in a two stroke penalty in stroke play or loss of hole in match play, followed by disqualification for a fourth violation.

A warning is any notice given to a competitor regarding pace of play.

A competitor's time to play begins when the competitor has had a reasonable opportunity to reach his or her ball and when it is the competitor's turn to play and can do so without interference or distraction. Penalties are applied individually, but more than one competitor in a group may be penalized.

In general, competitors in a group are subject to being timed at any time but specifically when the group is deemed to be out of position and over the allotted pace of play guidelines.

Pairings and Starting Times

The CGA is responsible for making pairings and starting times, for making these available to competitors and for conducting championships.

Preferences for starting times and pairings are **not** granted. Pairings are made to facilitate efficacious completion of a championship.

Pairings and starting times are posted at each host club prior to the last practice-round day, are available at the CGA office and on the CGA website.

Competitors are responsible for ascertaining starting times and should be ready to play at the assigned tee at least five minutes prior to the starting time.

Practice Rounds

Practice rounds before a championship generally are scheduled the day(s) before the event at the discretion of the host club. Competitors generally are granted one complimentary practice round before a championship. Use of golf carts may be required.

Multiple shots are not permitted during a practice round except on a putting green, provided play is not delayed.

Prizes

All prizes are determined by the CGA Championship Committee or by the duly-appointed CGA representative.

Prizes in CGA amateur championships comply with USGA Rules of Amateur Status (see Rules of Golf). Prize money for professional events or divisions is determined by field size. Prizes in junior championships comply with state high school athletic and otherwise applicable regulations.

In a championship featuring a permanent trophy, the current champion's home club has custody of the trophy until the scheduled date of the championship the following year. The champion from the preceding year has the responsibility to assure that the permanent trophy on display at his club arrives, in due time, at the next championship site. If this is not possible, the custodian club must notify the CGA office in advance of the championship dates.

Qualifying Events

Qualifying events are held for CGA championships which attract far more entries than can be accommodated in the championship starting field.

Qualifying Site Selection. Competitors are asked to identify on the entry form, in order, the qualifying sites they prefer.

If the field of the first-selected qualifying site is filled by the time a competitor's entry form is received by the CGA, the competitor will be moved to his/her second-selected site. If the field of the second choice is filled, the third choice is used and so on.

If a competitor **fails** to select a second (or subsequent) preference on his/her entry form, the CGA will list that player as an alternate. A competitor will not be allowed to change qualifying sites after entries close.

Rain-out Policy. In the event a qualifying round is canceled, the CGA reserves the right to choose qualifiers for the championship as follows:

1. from eligible competitors who made the cut in the specific championship the past two years the event was contested;
2. from eligible competitors who qualified for USGA Championships during the previous 24 months;
3. from points on the Carolinas Men's Rankings as of the last update.

If any spots in the championship field remain, a "blind draw" will determine the remaining competitors up to the total determined in advance by the Committee.

Score Cards

Each competitor is responsible for the accuracy of the score recorded for each hole but not for the addition of those scores.

In CGA competitions, a score card is deemed returned to the committee when the score is posted on the official scoreboard. In CGA conducted USGA qualifying, a score card is deemed returned when the player has exited the scoring area. No alteration may be made on a scorecard by a competitor after it is returned to the committee. Competitors are encouraged to remain in the scoreboard area until their scores are posted.

A competitor who fails to return a signed scorecard within 30 minutes of completion of the stipulated round is deemed to have failed to return a score for the round and can be listed on the scoreboard as a "No Card" (NC).

In match-play championships, score cards are not required. The winner of a match must report the result of that match to a CGA official immediately after completion of the match. Competitors are urged to check the scoreboard to see that match-play results are posted properly and to determine the starting time of the next-scheduled round.

The CGA reserves the right to reject an entry if the entrant was a "No Card" (NC) or "Did Not Show" (DNS) the previous year.

Television, Radio, Motion Picture, Video and Photographic Rights

Competitors in CGA championships grant and assign to the CGA, without limitation, their individual television, radio, motion picture, video, photographic and all other similar rights with respect to participating in CGA events.

Competitors also agree to refrain from any action which might interfere with the CGA's ownership of the rights granted and assigned to the CGA. All such rights are the property of and expressly reserved for, by and to the CGA. Any use thereof, without the expressed and written consent of the CGA, is forbidden.

Ties and Playoffs

Resolution of ties and playoff information are listed on CGA Local Rules sheets. As a general rule, these include:

- A tie for first place in a stroke-play championship is resolved by a hole-by-hole playoff beginning at a hole to be determined by the Committee. If a playoff involves more than two competitors, those other than the champion are deemed to tie for second place.
- In championships at which trophies are awarded to more than the champion, a hole-by-hole playoff determines the order of finish.
- In all other cases involving ties, prizes are split.
- In a match-play championship, the stipulated round will be extended until a winner is determined.
- Competitors or teams finishing at the same level in a match-play championship (such as semifinalists) receive identical prizes.

One-Day Tournament Program including One-Day Handicap, One-Day Four-Ball, Senior Four-Ball One-Day and Mid-Senior/Senior/Super Senior One-Day

Tournament Regulations

2010-11 USGA Rules of Golf govern play.

CGA championship regulations apply to one-day tournaments except as listed below.

Eligibility

A CGA One-Day Handicap Tournament (**One-Day**) is open to any amateur who is a member of a CGA member club and who has a CGA handicap index no more than 30 days old. Applicants for amateur reinstatement (A/R) are not eligible for these events.

A CGA One-Day Four-Ball Tournament (**One-Day Four-Ball**) is open to any amateur who is a member of a CGA member club and who has a CGA handicap index no more than 30 days old. Applicants for amateur reinstatement (A/R) are not eligible for these events.

A CGA Senior Four-Ball One-Day Tournament (**Senior Four-Ball One-Day**) is open to any male amateur who is a member of a CGA member club, who has a CGA handicap index no more than 30 days old and who has reached his 55th birthday by the day of the event. Applicants for amateur reinstatement (A/R) are not eligible for these events.

A CGA Mid-Senior/Senior/Super Senior One-Day tournament (**Mid Senior/Senior/Super Senior One-Day**) is open to any male amateur who is a member of a CGA member club, who has a CGA handicap index no more than 30 days old and who has reached his 45th birthday by the day of the event. Applicants for amateur reinstatement (A/R) are not eligible for these events.

Caddies and Spectator Carts

A player is prohibited from using a caddie during the stipulated round (Rule 6-4 Note, Appendix I). Spectators are not permitted to ride in a player's cart at any time or rent a spectator cart at any CGA one-day tournament (Rule 33-7).

Code of Conduct

CGA expects all competitors to adhere to the "Etiquette and Behavior on the Course" section of the USGA Rules of Golf. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct, did not start (DNS) or no card (NC). Failure to follow the CGA Code of Conduct may result in the competitor's suspension from participation in future CGA competitions.

Discontinuing Play

The CGA official-in-charge and the staff of the host club have the authority to discontinue play or cancel an event due to inclement weather or conditions. Competitors may discontinue play only if they consider themselves to be in danger from lightning or for some other factor, such as sudden illness, which the CGA official-in-charge considers satisfactory.

If an event is canceled, all entry fees will be refunded. No refunds are made to groups of four or individuals who fail to start due to inclement weather when an event is not canceled.

Refund Policy

Open Date to Close Date: Full refund minus \$25.00 administrative fee if entry accepted into tournament.

Day after Close Date to Day Prior to Tournament Date: 50% entry fee refunded regardless of reason.

Withdraw on Tournament Date: No refund for any reason. Alternates receive full refund.

Entry Information and Selection Process

Each one-day tournament program has separate entry forms which are available at the CGA office and on the CGA website, www.carolinasgolf.org.

A competitor with more than one CGA handicap index must use the **lowest** current index.

A check for insufficient funds may result in the competitor's indefinite suspension from CGA events. Each entry fee must be paid by check, cash, money order or online with a credit card. Each tournament entry form must be paid for by separate payments (i.e. one entry fee per check). When one-day and one-day four-ball tournaments are held on consecutive days, separate payments must be submitted for each day.

When senior four-ball one-day events are held on consecutive days, one payment may be submitted for both events.

Entry Selection Process: First 50% of available tournament spots are accepted on a first-come, first-served basis. For one-day handicap tournaments the first 50% of tournament spots are equally distributed between individual and group of four entries. After the first 50% of entries have been accepted then entries are accumulated for the remainder of the tournament Open/Close window. When a tournament field is oversubscribed, the remaining spots and alternates are selected based on a "blind draw" method with groups of four receiving preference. When one-day events are scheduled on consecutive days, priority in acceptance is given to those who enter both events. Competitor substitutions are allowed prior to and at registration, provided the substitutes are otherwise eligible. Alternates may show-up on a tournament day and fill a vacant spot if available. **However, on-site walk-up entries are not accepted.**

All player information must be filled out or entry(s) will be returned.

All entries are subject to approval by the CGA. By submitting an entry form, each competitor agrees to abide by all CGA and host club regulations, including dress code.

Practice rounds are generally not available for any one-day event and are not included in any entry fee.

Use of a golf cart is required at all CGA one-day, one-day four-ball, senior four-ball one-day and mid senior/senior/super senior one-day tournaments. Cart and range fees are included in tournament entry fees.

Faxed, e-mail, telephone, late or incomplete entry forms are not accepted.

Entries submitted without checks are not accepted. Unless otherwise specified, entry forms are to be returned to the CGA, PO Box 319, West End, NC 27376.

The CGA is not responsible for errors or delays made by any mail or delivery courier.

Tournament applications are not accepted until the tournament's opening date/time and are not accepted after the closing date/time. See the CGA website for open/close dates/times.

One-Day Events: Competitors must enter either as an individual or in groups of four.

One-Day Four-Ball Events: Competitors must enter as a group of **two** competitors. Teams are pre-flighted according to team composition/handicap and paired prior to play.

Partner substitutions are allowed with prior approval. Partner substitutions made within five days of the tournament date must be approved by the CGA office. Any on-site partner changes may result in the new partner playing at scratch.

Senior Four-Ball One-Day Events: Competitors must enter as a group of **two** competitors. Teams are pre-flighted according to total team handicap and paired prior to play.

Partner substitutions are allowed with prior approval. Partner substitutions made within five days of the tournament date must be approved by the CGA office. Any on-site partner changes may result in the new partner playing at scratch and competing within the same flight.

Mid-Senior/Senior/Super Senior One-Day Events: Competitors must enter as an individual.

Format

One-Day: Format is 18 holes of individual stroke play with 100% course handicap unless altered by the Committee. Gross and net prizes are awarded. Competitors are grouped based upon gender, age and handicap index. Men's Flight A is for competitors with handicap indexes of 7.9 or less. Men's Flight B is for competitors with handicap indexes of 8.0 or greater. Senior Men's Flight is for male competitors over age 55 regardless of handicap index. Women's Flight is for all female competitors regardless of handicap index. There must be at least 6 participants to constitute a flight. Otherwise, those players will compete in another flight with their handicap being adjusted for any difference in course rating.

One-Day Four-Ball: Format is 18 holes of four-ball stroke play, both gross and net. Net scores are based on 90 percent of a competitor's course handicap, according to USGA handicap procedures. If the difference between the partners' course handicaps exceeds eight strokes, then an additional 10 percent reduction will be applied to both team members. Teams are grouped into three flights according to team composition/handicap (Men A, Men B, Mixed/Women). A competitor's course handicap is limited to 30 strokes or less.

Senior Four-Ball One-Day: Format is 18 holes of four-ball stroke play, both gross and net. Net scores are based on 90 percent of a competitor's course handicap, according to USGA handicap procedures. If the difference between the partners' course handicaps exceeds eight strokes, then an additional 10 percent reduction will be applied to both team members. Teams are grouped into three flights according to total team handicap. A competitor's course handicap is limited to 18 strokes or less.

Mid-Senior/Senior/Super Senior One-Day: Format is 18 holes of individual stroke play with 100% course handicap unless altered by the Committee. Gross and net prizes are awarded. Entrants placed into divisions according to age. Age divisions: Mid-Senior (45-49), Mid-Senior (50-54); Senior (55-59); Senior (60-64); Super Senior (65-69); Super Senior (70+). There must be at least 6 participants to constitute a flight. Otherwise, those

players will compete in another flight.

Local Rules

USGA Rules of Golf govern all play. Local rules are posted at the starter's desk. The following local rules are in effect at all one-day tournament program events.

*The "One-Ball Rule" is **not** in effect.*

***Embedded ball** relief is "**through the green**" except in sand not in closely mown areas.*

***Regular water hazards** are **identified** by yellow stakes and **defined** by yellow lines. Stakes and lines are deemed to be in a hazard.*

***Lateral water hazards** are **identified** by red stakes and **defined** by red lines. Stakes and lines are deemed to be in a hazard.*

***Ground under repair** is defined by white lines. White-lined areas tying into a cart path are deemed to be part of that obstruction.*

***Out of bounds** is defined by the **inside points** of white stakes **at ground level** and other items as defined in the Notice to Players.*

***Distance Measuring Devices:** A player may obtain distance information by using a device that measures distance only. However, if, during a stipulated round, a player uses a distance-measuring device that is designed to gauge or measure other conditions that might affect his play (e.g., gradient, wind-speed, temperature, etc.), the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional functions are actually used.*

*At clubs which have shoe and **spike restrictions**, the penalty for non-compliance of the club rule is **disqualification**.*

*All club **dress codes** will be observed. The penalty for non-compliance is **disqualification**.*

The penalty for non-compliance of the CGA prohibition of cell phones, headphones, MP3 players, beepers, pagers and the like is a warning for the first offense and disqualification for the second offense.

Prizes

The CGA official-in-charge reserves the right to withhold any prize won by a competitor whose handicap index is considered unrealistic or who has participated in a disproportionate share of CGA prize collections.

The CGA official-in-charge may adjust a competitor's course handicap prior to play, based on the competitor's previous tournament scores.

***One-Day:** Prizes are awarded for gross and net scores. The number of net prizes is determined by the number of entries. If winners are not available to accept prizes, and no address is available, prizes will be mailed to the individual whose address is listed first on the entry form. Ties are broken on the score card using the USGA recommended method of using the total for the back nine holes, the last six holes, last three holes and the 18th hole. If a tie still remains, the scorecards will be matches beginning with the first hole until the tie is broken. Gross ties use gross scores. Net ties use net scores. Gross ties are determined first. First place winners will be eligible to compete in the One-Day Tournament of Champions.*

A player is disqualified if his net score beats the course rating by eight or more strokes and beats the next best net score by four or more strokes.

***One-Day Four-Ball:** Prizes are awarded for gross and net scores in all flights. Ties are broken on the score card*

using the USGA recommended method of using the total for the back nine holes, the last six holes, last three holes and the 18th hole. If a tie still remains, the scorecards will be matches beginning with the first hole until the tie is broken. Gross ties use gross scores. Net ties use net scores. Gross ties are determined first. First place winners will be eligible to compete in the One-Day Four-Ball Tournament of Champions.

A team is disqualified from a tournament if they beat the course rating by 12 strokes or more AND beat the next best score by four strokes or more.

Senior Four-Ball One-Day: Prizes are awarded for gross and net scores in all flights. Ties are broken on the score card using the USGA recommended method of using the total for the back nine holes, the last six holes, last three holes and the 18th hole. If a tie still remains, the scorecards will be matches beginning with the first hole until the tie is broken. Gross ties use gross scores. Net ties use net scores. Gross ties are determined first. First place winners will be eligible to compete in the Senior Four-Ball One-Day Tournament of Champions.

A team is disqualified from a tournament if they beat the course rating by 12 strokes or more AND beat the next best score by four strokes or more.

Mid-Senior/Senior/Super Senior One-Day: Prizes are awarded for gross and net scores in all flights. Ties are broken on the score card using the USGA recommended method of using the total for the back nine holes, the last six holes, last three holes and the 18th hole. If a tie still remains, the score cards will be matches beginning with the first hole until the tie is broken. Gross ties use gross scores. Net ties use net scores. Gross ties are determined first. First place winners will be eligible to compete in the One-Day Tournament of Champions.

A player is disqualified if his net score beats the course rating by eight or more strokes and beats the next best net score by four or more strokes.

Score Cards

A score card is deemed to be returned when the score(s) have been posted on the official scoreboard. No alteration to a card may be made after it has been returned to the committee.

The CGA official-in-charge is responsible for applying course handicaps to scores.

A competitor who fails to return a score card within 30 minutes of completion of the stipulated round is denoted as a "No Card" (NC). Competitors that are a "NC" are suspended from the next four CGA one-day tournaments.

One-Day and Mid-Senior/Senior/Super Senior One-Day: Score cards provided by the CGA will contain a player's name, course handicap and tees to play. Score card must be signed by the player and his marker. A duplicate score card can be made if the original is lost.

The CGA will post adjusted gross scores back to a player's home club handicap.

One-Day Four-Ball and Senior Four-Ball One-Day: Score cards provided by the CGA will contain both player's names, allocation of strokes received and tees to play. The score to count must be individually identifiable. To expedite the scoring process, teams are requested to list the best ball gross and net on the score card where provided. Only one player from the competitor's side and the marker's side must sign the score card before it is returned. A duplicate score card can be made if the original is lost.

The USGA Rules of Golf requires a marker to record only the gross score of the player whose net score is to count (Rule 31-3). The CGA scoring policy requires markers to record ALL hole scores for all players for handicap purposes. This enables the CGA to post scores to each player's handicap scoring record. Please do not post these scores yourself as this will duplicate the CGA's effort. Section 5-2f of the USGA handicap manual allows a tournament committee to post scores for players. The CGA will do this automatically for you. How to record scores for holes not completed: For unfinished holes, enter the score you most likely would have made (more often than not). For holes not started, enter par plus any handicap strokes you would have received on the hole. Failure to record individual hole scores may jeopardize participation in future CGA one-day tournaments.

Official Starting Time

Tee Times - The clock at the tee (1st or 10th) where the player begins his/her stipulated round is the official time of starting. Starters will not page players in advance of their starting time. Players should report to the tee at least five minutes prior to their starting time. Rule 6-3b, Note is in effect (Five Minute Rule).

Shotgun or Simultaneous Start - A player is responsible for being at the assigned tee promptly to begin play on time. If a player arrives late but within five minutes after the assigned starting time, the penalty for failure to start on time is two strokes at the first hole instead of disqualification (Rule 6-3b, Note). The assigned starting time for shotgun events is when a) a horn or siren is sounded, b) if no horn or siren is used, when the group can play without interference or c) if the player is in the second group to start on an assigned hole, when that group can play without interference.

A competitor who fails to show is denoted as a "Did Not Start" (DNS). Competitors that are a "DNS" are suspended from the next four CGA one-day tournaments.

Tarheel Youth Golf Association (TYGA)

Tournament Regulations

2010-11 USGA Rules of Golf govern play.

These regulations apply to TYGA tournaments.

Eligibility

Each competitor must be a member of the Tarheel Youth Golf Association (TYGA). Each member must be 18 years old or younger as of the tournament date for "one-day" and "tour championship" events and 18 years old or younger as of the last tournament day for all multi-day events. Also, the junior must reside in North Carolina.

Entry Requirements

Each competitor must complete an official entry form. Entries received prior to the opening date will be returned. Entries are accepted until 11:59 p.m. of the closing date or until the field is filled. Entries must be returned to the Carolinas Golf Association.

Fax, telephone, e-mail, late, or incomplete entries will not be accepted.

Confirmation of acceptance will be sent via email. No refunds are given after entries close. The CGA is not responsible for error and/or delays with any mail courier or Internet service provider.

Entries are subject to rejection at any time, including during the tournament, by the Carolinas Golf Association, the Tarheel Youth Golf Association, or the host club. The reason may include unbecoming conduct. Players failing to show without either notifying the CGA office or the host site prior to the event may be subject to rejection from future events.

Caddies

A caddie must be 18 or younger and must walk.

Discontinuing Play and Cancellations

The TYGA official-in-charge and the staff of the host club have the authority to discontinue play or cancel a tournament due to inclement weather. If a tournament is cancelled prior to the day or day of play, fees will be

refunded.

Format

Lunch is provided by the CGA and the host club. Each competitor must walk and carry his/her own bag (pull carts are allowed if club agrees) during the stipulated round, unless the competitor employs a caddie.

Divisions will be as follows: Boys and Girls 8-11, Boys 12-13, Boys 14-15, Boys 16-17, Girls 12-13, Girls 14-18. Practice rounds are not included in the tournament entry fee.

Tobacco and alcohol products are prohibited. USGA Rules of Golf govern all competitions. Local rules will be distributed at each site and are located at www.tyga.org.

Refund Policy

No refunds will be given after entries close.

Score Cards

A card is deemed returned to the committee when the score is posted on the official scoreboard. No alteration may be made on a scorecard by a competitor after it is returned to the committee. Competitors are encouraged to remain in the scoreboard area until their scores are posted.

Starting Times

Tee time assignments will be made available at the host site seven days prior to the event and at www.tyga.org.

Middle School Championship

Format

36-holes of stroke play over two days.

Number of Players/Teams

90 players will be allowed into the state championship, with a total of 13 teams maximum. Number of individuals will be determined by qualifying team rosters used at regional qualifying.

Team Rosters

Team members may change after qualifying, but number of players used may not.

Entry Information

First 10 teams and first 20 individuals will be accepted. Extra spots created by lack of six-player teams will be filled with individuals.

Rules note: The "double par" rule will not be allowed during regional qualifying or the state championship.

Prizes

Trophies are awarded to the championship team, all members of the championship team, the individual boys' champion and the individual girls' champion.

Eligibility:

All team members must attend the same middle school. A middle school student is defined as a student who is in grades 6-8 of the current school year. A maximum of **four** players may represent a school, however, **if no girls are on the team, that school is limited to three participants**. Any number of girls may play for a school. Home-schooled players and private school students and teams are allowed.
