

# 18<sup>th</sup> Women's Match Play Championship of the Carolinas Golf Association

July 7-9, 2015

#### ELIGIBILITY

Entry is open to any female amateur golfer who has reached her 13<sup>th</sup> birthday by July 7, 2015, is a legal resident of North Carolina or South Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has an active GHIN® USGA Handicap Index® at a CGA member club that does not exceed 40.4. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf". For complete residency and eligibility requirements, refer to the CGA Tournament Manual

Championship field size=72 players.

#### ENTRIES AND ALTERNATES

All players, including those exempt, must complete an official entry form. Online entry applications may be completed at www.carolinasgolf.org. Fax, email, telephone, incomplete and illegible entries received before the opening date and after the closing date are not accepted.

Exempt players are accepted at time of entry. Non-exempt entries are accumulated for the entire open/close window. The final field is comprised of players with lowest Handicap Indexes. Championship division has priority in acceptance. Alternates are ranked according to Handicap Index.

The CGA is not responsible for errors or delays by any mail courier or Internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance is sent to players when their status is determined. Status may be checked at www.carolinasgolf.org. The entry fee must be paid by each player and must accompany this form. Only one entry fee per check. Make check payable to the Carolinas Golf Association. Detach, sign and mail the entry form with the \$135.00 entry fee to the CGA, 140 Ridge Road, Southern Pines, NC 28387. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) are suspended from next year's Carolinas Women's Match Play Championship.

#### **REFUND POLICY**

Entry fee refund policy schedule:

Open Date to Day Prior to Championship Date: Full refund minus \$30.00 administrative fee regardless of reason if entry accepted into championship.

Withdraw on Championship Date; No-Shows: No refund for any reason.

Alternates: Full refund if player does not gain entry into the championship.

#### RULES

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship including sectional qualifying. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted. Dress code: No cut-off shorts or denim, no shorts shorter than four inches above the knees, no tank tops or t-shirts, and all shirts must have either a collar or sleeves.

#### CART FEES; GOLF CARTS; CADDIES; SPECTATORS

Practice Rounds: Cart rental is mandatory for practice rounds. Competitors pay host club directly for practice round fees.

Championship Rounds: Championship round cart & range fees for first two days is included in the entry fee. Players are responsible for final day cart & range fees.

Caddies: Caddies are allowed for championship rounds. Caddies will not be available at host club.

Caddie/Spectator Cart Policy: During the play of a hole, either the player or his caddie may ride in a golf cart but not both at the same time. Spectators are not allowed to ride in a player's golf cart at any time. Club owned spectator carts are not allowed except as provided in the CGA Tournament Manual.

#### FORMAT

Format is 18 holes of stroke play to determine seeding and flights for match play. Players have the option to compete in either the "Championship" division or "Tournament" division.

Championship Division:

Championship division will play from the "championship" tees and compete using gross scores. Championship flight is comprised of 16 players that will compete for the overall title. Remaining championship division players are flighted according to number of entries. On-course playoff is used to break a tie for the last spot in the championship flight. A blind draw is used to determine the last spot in all other flights. Mallory Hetzel of Waynesville, NC is the defending champion and is seeded number one for match play if otherwise eligible.

(New Format for 2015) Tournament Division:

Tournament division plays a shorter course and is ineligible for the overall championship. Tournament division will play from the "tournament" tees and will compete using gross scores for stroke play qualifying and net scores for match play. Matches will be stroked off the low ball (lower handicap competitor playing at scratch and the higher handicap competitor receiving the difference in course handicaps between the two competitors). The number of flights and flight sizes are determined based on the number of entries.

The CGA reserves the right to adjust any flights based on the entries received.

#### YARDAGE

Championship Division=5900 yards Tournament Division=5150 vards

#### PRIZES

Prizes and merchandise are awarded to the champion and runner-up, flight winners and runners-up, and to the stroke play qualifying medalist. Merchandise is awarded to all championship flight qualifiers.

#### EXEMPTIONS

First round. 18 holes of stroke play. Field divided into flights by scores for match play.

#### Wednesday, July 8

Championship flight. First and quarterfinal round matches (18 holes each). All other flights: First round matches and semifinal round matches (18 holes).

#### Thursday, July 9

Championship flight. Semifinal and championship matches (18 holes each). All other flights: Consolation and final matches (18 holes).
