ELIGIBILITY

Entry is open to any female amateur golfer who has not reached her 19th birthday by June 21, 2013, who has not started college, is a legal resident of North Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA Handicap Index® at a CGA member club that does not exceed **18.4**. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct or cell phone use during a stipulated round. All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf". For complete residency and eligibility requirements, refer to the CGA Tournament Manual at the CGA website, (www.carolinasgolf.org). Championship field size=90 players.

ENTRIES

All players, including those exempt, must complete an official entry form. Online entry applications may be completed at www.carolinasgolf.org. Fax, e-mail, telephone, incomplete, illegible, or entries received before the opening date and after the closing date, are not accepted.

Players gain entry into the championship on a first-come, first-serve basis.

The CGA is not responsible for errors or delays by any mail courier or internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance is sent to players when their status is determined. Status may be checked at www.carolinasgolf.org. The entry fee must be paid by each player and must accompany this form. Only one entry fee per check. Make check payable to the Carolinas Golf Association. Detach, sign and mail the entry form with the **\$90.00** entry fee to the CGA, PO Box 319, West End, NC 27376. A player whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Players who "Did Not Show" (DNS) or "No Card" (NC) are suspended from next year's NC Junior Girls Championship.

REFUND POLICY

Entry fee refund policy schedule:

Open Date to Close Date: Full refund minus \$25.00 administrative fee if entry accepted into championship.

Day after Close Date to Day Prior to Championship Date: Full refund minus \$45.00 administrative fee refunded regardless of reason if entry accepted into championship.

Withdraw on Championship Date: No refund for any reason.

Alternates not gaining entry into the tournament receive a full refund.

RULES

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

FORMAT

The championship format is match play with an 18 hole stroke play qualifier (Tuesday, June 18th) to determine the seeding for match play. The top 32 scores from the stroke play qualifier will advance to match play. Defending champion Isabella Rusher of Salisbury, NC will be seeded number one for match play if otherwise eligible.

YARDAGES

Approximately 6,000 yards, par 72.

AGE DIVISIONS

There are no age divisions.

PRIZES

Trophies are awarded to the champion, runner-up, semifinalists, and stroke play qualifying medalist.

TEAM MATCHES

Champion will be invited to represent the CGA in the Mid-Atlantic Junior Girls Team Matches at the Country Club of North Carolina in Pinehurst, NC on July 27-28, 2013.
