## **ELIGIBILITY (New for 2013)**

Entry is open to any team comprised of a parent and child, regardless of age, in any gender combination **excluding male-male**. **Step-parents, grandparents and in-laws are eligible.** At least one member of each team must: 1. be a legal resident of one of the Carolinas; 2. be a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and have a current USGA Handicap Index® at a CGA member club **or** is a golf professional employed at a CGA member club. A team is eligible if one partner is an amateur member of a CGA member club or if one partner is a golf professional employed by a CGA member club. **Pro-Pro teams are NOT eligible.** Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. The minimum age for entry is eight years as of the tournament date. ## **ENTRIES**

All teams must complete an official entry form. Online entry applications may be completed at [www.carolinasgolf.org](http://www.carolinasgolf.org). **Fax, e-mail, telephone, incomplete, illegible, or entries received before the opening date and after the closing date, are not accepted.**

**The first 60 entries are accepted on a first come, first served basis. Alternate teams are ranked according to order of entry. Course assignment and starting times are sent to the first player listed on this form.**

The CGA is not responsible for errors or delays by any mail courier or internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance and tournament information is sent to the **first** player listed on this form when their status has been determined. Status may be checked at [www.carolinasgolf.org](http://www.carolinasgolf.org). The entry fee must be paid by each team and must accompany this form: **Only one entry fee per check.** Make check payable to the Carolinas Golf Association. Detach, sign and mail the entry form with the \$110 entry fee to the CGA, PO Box 319, West End, NC 27376. A team whose check is returned for insufficient funds may be disqualified indefinitely from CGA competitions. Teams who "Did Not Show" (DNS) or "No Card" (NC) are suspended from next year's Carolinas Parent-Child Championship.

## **REFUND POLICY**

Entry fee refund policy schedule:

Open Date to Close Date: Full refund minus \$25.00 administrative fee if entry accepted into championship.

Day after Close Date to Day Prior to Championship Date: Full refund minus \$50.00 administrative fee refunded regardless of reason if entry accepted into championship.

Withdraw on Championship Date: No refund for any reason. Alternates not gaining entry into the tournament receive a full refund.

## **RULES**

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship including sectional qualifying. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

## **COURSE FEES; GOLF CARTS; CADDIES; SPECTATORS**

**Championship round cart and range fees are included in the entry fee.** Cart use is mandatory during the championship round.

Cart rental and use is mandatory for practice rounds.

Caddies are allowed for championship rounds. A player may provide his own caddie. Caddies will not be available at host club.

Caddie/Spectator Cart Policy: During the play of a hole, either the player or his caddie may ride in a golf cart but not both at the same time. Spectators are not allowed to ride in a player's golf cart at any time. Club owned spectator carts are not allowed except as provided in the CGA Tournament Manual.

## **FORMAT**

Each team plays alternate shot except that both team members hit from each tee and then select the ball to be played (modified alternate shot). A team must complete the hole with the ball selected.

Teams select the division in which to compete if eligible:

**Amateur Division:** Team comprised of two amateurs. Overall champions are determined from this division. Gross scores only. Flights are determined by \*team handicap index. Yardage is dependent upon gender, age and amateur or professional status.

**Open (Pro-Am) Division:** Team comprised of one golf professional and one amateur (or an amateur awaiting reinstatement "A/R"). Open division competes at gross and net. Net scores are calculated using 40% of the amateur partners' course handicap. Golf professionals play at scratch handicap.

\*Team handicap index is computed by adding 2/3 of the lower handicap index to 1/3 of the higher handicap index.

Approximate Yardage (\*Note: yardage is subject to change):

Amateur Males age 14 & up=6100 yards

Amateur Females age 14 & up and Professional Females=5400 yards

13 & Under Boys & Girls and Females age 50+=4700 yards

Professional Males=6600 yards

Note: CGA reserves the right to adjust the format dependent upon the number of entries.

## **PRIZES**

Merchandise and trophies are awarded to the overall champion. Merchandise is distributed in each division to low net winners based upon the number of entries. Ties for prizes are split except for the overall champion, which is determined by an on-course playoff.

## **EXEMPTIONS**

There are no exemptions for this championship.

Championship round. 18 holes of modified alternate shot.
