ELIGIBILITY

Entry is open to any female amateur golfer who has reached her 13th birthday by August 9, 2016, is a legal resident of North Carolina or South Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has an active GHIN® USGA Handicap Index® at a CGA member club. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct. All players must conform to the *USGA Rules of Amateur Status* as specified in *The Rules of Golf*. For complete residency and eligibility requirements, refer to the [CGA Tournament Manual](#).
Championship field size: 56 teams.

ENTRIES

All players, including those exempt, must register online at www.carolinagolf.org. Mail-in applications are no longer accepted for this event. Fax, mail, e-mail, telephone, incomplete, illegible, or entries received before the opening date and after the closing date, are not accepted. Entries are accumulated for the entire open/close window. Exempt teams are accepted at time of entry. The remainder of the field is selected after entries close with the lowest team handicap indexes. Alternates are ranked according to team handicap index.

The CGA is not responsible for errors or delays by any internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance and tournament information is sent to players when their status has been determined. Status may be checked at www.carolinagolf.org. Teams who "Did Not Show" (DNS) or "No Card" (NC) are suspended from next year's Carolinas Women's Four-Ball Championship.

REFUND POLICY

Entry fee refund policy schedule:

Open Date to Day Prior to Championship Date: Full refund minus \$30.00 administrative fee regardless of reason if entry accepted into championship.

Withdraw on Championship Date; No-Shows: No refund for any reason.

Alternates: Full refund if player does not gain entry into the championship.

RULES

USGA *Rules of Golf* govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted. Dress code: No cut-off shorts or denim, no shorts shorter than four inches above the knees, no tank tops or t-shirts, and all shirts must have either a collar or sleeves.

COURSE FEES; GOLF CARTS; CADDIES; SPECTATORS

Practice Rounds: Cart rental is mandatory for practice rounds.

Championship Rounds: Daily cart and range fees are included in the entry fee. Cart use is mandatory during championship rounds by either the player or her caddy. A player's equipment must be transported on her assigned cart.

Caddies: Caddies are allowed for championship rounds. A player may provide her own caddy. Caddies will not be available at host club.

Caddy/Spectator Cart Policy: During the play of a hole, either the player or her caddy may ride in a golf cart but not both at the same time. Spectators are not allowed to ride in a player's golf cart at any time. Club owned spectator carts are not allowed except as provided in the CGA Tournament Manual.

FORMAT

The championship is conducted at 36 holes of four-ball stroke play. All players regardless of Handicap Index have the option to play the *Championship Division* (approximately 6000 yards), the *Carolinas Division* (approximately 5200 yards), or the *Senior Division* (approximately 5200 yards). The *Senior Division* will be comprised of teams in which both players have reached their 50th birthday by August 9, 2016.

This competition will include gross scores only. Only players in the *Championship Division* will be eligible for overall champion. Teams will be pre-flighted within their division based on the combined team Handicap Index.

A tie for Overall Champion is determined by an on-course playoff. All other ties will be broken by scorecard playoff.

PRIZES

The Overall Champion team receives merchandise and trophies. Prizes are awarded to the low scorers in each flight.

EXEMPTIONS

Players in the following categories are exempt if otherwise eligible. A complete list of exempt players is available on page 2.

1. Champions of the Carolinas Women's Four-Ball Championship since 2006.
2. One exemption for championship host club.

*Exempt team members must compete on the same team or with another exempt player.

First round. 18 holes of four-ball stroke play (tee times).

Wednesday, August 10

Final round. 18 holes of four-ball stroke play (shotgun).

Awards luncheon immediately following completion of play.
