# **ELIGIBILITY**

Entry is open to any female amateur golfer ages 12-18 as of June 16, 2017, who has not started college, is a legal resident of North Carolina, is a member in good standing of a club which is a member of the Carolinas Golf Association (CGA) and has a current USGA Handicap Index® at a CGA member club that does not exceed 18.4. Entries are subject to rejection at any time, including during the event, by the CGA or the host club. The reason for rejection may include unbecoming conduct or cell phone use during a stipulated round. All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf". For complete residency and eligibility requirements, refer to the CGA Tournament Manual at the CGA website, (www.carolinasgolf.org). Championship field size=90 players.

# **ENTRIES**

All players must enter online at www.carolinasgolf.org. Players gain entry into the championship on a first-come, first-served basis. The CGA is not responsible for errors or delays by any internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance is sent to players when their status is determined. Status may be checked at www.carolinasgolf.org. Players who "Did Not Show" (DNS) or "No Card" (NC) are suspended from next year's NC Junior Girls' Championship.

# **REFUND POLICY**

Entry fee refund policy schedule:

Open Date to Day Prior to Championship Date: Full refund minus \$30.00 administrative fee if entry accepted into championship.

Withdraw on Championship Date: No refund for any reason. Alternates not gaining entry into the tournament receive a full refund.

#### **RULES**

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The CGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the championship. The competition is closed when the championship trophy has been presented. Special requests for starting times or pairings are not granted.

#### **FORMAT**

The championship format is match play with a 36-hole stroke play qualifier (June 13th and June 14th) to determine the seeding for match play. The top 15 scores from the stroke play qualifier will advance to match play. Defending champion Emily Hawkins will be seeded #1 for match play. Once a player loses a match, they are eliminated from the competition. There are no consolation matches.

# **YARDAGES**

Approximately 5,994 yards, par 72 (75.3/142).

# **AGE DIVISIONS**

There are no age divisions.

# **PRIZES**

Trophies are awarded to the champion, runner-up, semifinalists, quarterfinalists and stroke play qualifying medalist.

# TEAM MATCHES

Champion will be invited to represent the CGA in the Mid-Atlantic Junior Girls' Team Matches at Scotch Hall Preserve in Merry Hill, NC on July 29-30, 2017.
